Subject: 2020 + 2021 Annual General Meetings – Notice and Proxy Form

Background

The UNA Board and staff have been preparing for in-person Annual General Meetings (AGMs) to be held on September 30, 2021.

As the number of COVID cases continues to rise, and further restrictions have been implemented, it would be prudent to consider changing the format of the AGMs to an electronic meeting format.

Also, subsequent to setting the date for holding the AGMs, a new National Day of Truth and Reconciliation was announced, and this day of commemoration is set for September 30, 2021. This day will be observed federally, provincially and by the UNA.

Because of these two considerations it is recommended that the UNA host the 2020 and 2021 AGMs online via Zoom on September 29, 2021.

Decision Requested

- 1. THAT the Board confirm the following items for the 2020 + 2021 Annual General Meetings:
 - a. THAT the UNA hold the 2020 and 2021 Annual General Meetings back-to-back on September 29, 2021 commencing at 7:00 pm online via Zoom.
 - b. THAT the voting format for both regular voting and proxy voting take place via show of hands through Zoom.
 - c. THAT all UNA Directors be available to receive proxies for voting.
- 2. THAT the Board approve the attached 2020 Notice of AGM and Proxy Form.
- 3. THAT the Board approve the attached 2021 Notice of AGM and Proxy Form.

Discussion

The 2020 and 2021 UNA AGMs are scheduled to take place in-person on September 30, 2021. For the reasons noted above it is recommended that the UNA change the date and meeting format and host the 2020 and 2021 AGMs online via Zoom on September 29, 2021.



UNA BOARD MEETING OPEN SESSION

The switch of the meeting format and date requires the Board to confirm new Notices of AGM and proxy forms.

The attached Notice of AGM and Proxy Forms mirror the format reviewed by the Board for a proposed electronic AGM in 2020 – including voting instructions and instructions on how to submit proxy forms. If the UNA receives proxy forms the "voting weight" of the Director or UNA Member assigned the proxy will be highlighted in their personal meeting id for the Zoom meeting.

The ability of the UNA to hold the AGMs electronically is a result of changes that the Province made to the Societies Act in May 2021 to enable electronic meetings. Highlights of these changes are as per below:

Societies can hold corporate meetings by telephone "or other communications medium" if:

- The notice of the meeting sets out the communications medium to be used and instructions for attending, participating and voting at the meeting;
- All persons attending the meeting are able to participate;
- The society permits and facilitates participation in the meeting;
- The bylaws don't prohibit holding electronic meetings.

The provisions are framed to allow electronic meetings, except to the extent that a Society's bylaws provide otherwise. Our solicitor has reviewed our bylaws and confirmed that there is no language in the bylaws that would prohibit the holding of electronic meetings.

In terms of next steps, if the Board approves the format and date change, staff will email out the Notice of AGM and Proxy Forms to UNA members. It is anticipated that the Board and staff will perform a test run prior to the AGM – at a date and time to be confirmed. Communications staff will also work with the Board Chair and the Chair of the Finance and Audit Committee, as well as the Chief Administrative Officer to prepare the AGM presentations.

Financial Implications

There is currently \$30,000 budgeted for an AGM and election. These two processes are now separate, and costs may change this year due to changes – but staff are hopeful that the budgeted amount will be sufficient.
